The estimated requirement of Quick Lime powder per month is around 25 tones.

## The Specification of Quick Lime powder is as follows:

# The minimum lime content as Calcium Oxide, (CaO) – 75 to 80 %

- 2. The Supplier shall submit the test report and weigh bridge receipt of approved weigh bridge for Quick Lime powder along with the supply of each consignment at the office of KITCO Ltd at CETP, CSEZ. However, if the material supplied does not meet the specification on testing at CETP lab or at any other Govt. approved lab upon delivery, the lot will be rejected or payment will be made only on a pro- rata basis according to the percentage of lime content as CaO.
- 3. The Tender shall be submitted in the prescribed format
- 4. The price quoted for supply of Quick Lime powder shall be valid for one year. This period shall be reckoned from the date on which the Managing Director, KITCO issues written orders to commence the supply of Lime.
