The Committee noted that installation of lift is a statutory requirement under "The Rights of Persons with Disabilities Act 2016". The committee also noted that the requirements under Rule 173 (xx) of GFR 2017 regarding receipt of single tender has been followed in the instant case.


After due deliberation the authority decided to approve for awarding the work of **Supply, Installation, Testing & Commissioning of Passenger Lift at CSEZ Admn Building** at the following quoted rate.
