Section-II

1.0 INTRODUCTION

Cochin Special Economic Zone (CSEZ) is a Special Economic Zone functioning under the Administrative control of the Department of Commerce, Ministry of Commerce & Industry, Government of India. The Zone acts as an export hub for the industries whose products are marketed overseas. Cochin Special Economic Zone Authority (CSEZA) is an authority created under Special Economic Zone Act, 2005. It functions as an infrastructure facilitator of the Zone by assuming the role of a Developer of the Zone. CSEZA distributes power and water required by the industries in the Zone. It also manages a common effluent treatment plant within the Zone. CSEZA has appointed **WAPCOS Limited**, A Government of India Undertaking under the Ministry of Water Resources, River Development and Ganga Rejuvenation as '*Owner's Engineer*'. WAPCOS intends to select an agency for Supply of 200 mm dia Ductile Iron Pipe and fitting for the replacement of water distribution pipeline for Cochin Special Economic Zone (CSEZ), Kakkanad, Cochin in an efficient manner through engagement of reputed agencies having relevant experience.

2.0 CONDITIONS OF CONTRACT

2.1 Validity of offer

The offer shall be valid for a period of 90 days from the date of submission.

2.2 Rates

The rates quoted shall include all the taxes, duties, levies, cess etc. in respect of this contract shall be payable by the contractor and WAPCOS shall not entertain any claim whatsoever in this respect.

Cost for all the statutory and safety precautions shall include in the rates quoted and WAPCOS will not entertain any claim, whatsoever in this respect. The rates shall be firm for the period from the date of the award of contract for a period of 90 days or till the completion and release of payment for the work and no escalation whatsoever will be allowed during this period. If pursuant to or under any law, notification or order any royalty, cess or the like becomes payable by the WAPCOS and does not any time become payable by the contractor to the State Government, Local authorities in respect of any material used by the contractor in the works, then in such a case, it shall be lawful to the WAPCOS and it will have the right and be entitled to recover the amount paid in the circumstances as aforesaid from dues of the contractor

2.3 Billing and Payment

Bidders are advised to execute LUT and should be able to supply goods and services at zero rate through LUT. The CSEZ Developers/units have been exempted from Payment of Customs Duty for goods or services imported into SEZ for its authorised operations in terms of Section 26 of SEZ Act, 2005. As per 16(1) of Chapter VII of IGST Act, all supplies of goods or services or both to SEZ Developer and Units are zero rated. Accordingly bidder shall submit LUT if already registered. If not registered till date of submission of bid, bidder

shall hereby agree that they will get registered before submission of bills. For the purpose of availing this exemption, billing address should be taken as “The Chairman, CSEZ Administrative Building, and Kakkanad -682037.”

Invoice maybe raised for part payment after completion of each part of the BOQ, as per directions from Engineer-In-Charge.

2.4 Obligations of WAPCOS/CSEZA

WAPCOS/CSEZA shall -

- Facilitate entry pass

2.5 Defect Liability Period

The Contractor is expected to rectify any defects found in the Works due to defective construction practice or poor quality of work and/or material. The Defect Liability Period for the work is as follows:

1. Refilling of cylinder is 1 year
2. Supply of new extinguishers is 2 years

Notwithstanding anything mentioned with respect to the period of limitation of defect liability here in this contract, the contractor shall be liable to compensate the Client for any damages sustained either to the Project or to the Client/any third party (by virtue of the Project) attributable either to the defects/fault in the design of the Project or to the defects in materials/workmanship which could have been detected during the period of the Project. If such above rectification is not done by the contractor, the Client shall have the right to rectify the defect during the defect liability period and recover the expenses/cost incurred in such instance, along with compensation, if any from the contractor.

2.6 Time period

- Supply part of the BOQ (Part A) has to be completed within 1 month of the issue of the work order.
- Refilling of fire extinguishers in Lot No 1 (Part B) has to be completed within 2 week of the issue of the work order.
- Refilling of fire extinguishers in Lot No 2 (Part C) has to be completed within 1 month of handing over the refilled fire extinguishers in Lot No 1

3.0 INSTRUCTIONS TO BIDDERS
