1.0 CONDITIONS OF CONTRACT

1.1 Validity of offer

The offer shall be valid for a period of 90 days from the date of submission.

1.2 Rates

The rates quoted shall include all the taxes, duties, levies, cess etc. in respect of this contract shall be payable by the contractor and WAPCOS shall not entertain any claim whatsoever in this respect.

Cost for all the statutory and safety precautions shall include in the rates quoted and WAPCOS will not entertain any claim, whatsoever in this respect. The rates shall be firm for the period from the date of the award of contract for a period of 90 days or till the completion and release of payment for the work and no escalation whatsoever will be allowed during this period. If pursuant to or under any law, notification or order any royalty, cess or the like becomes payable by the WAPCOS and does not any time become payable by the contractor to the State Government, Local authorities in respect of any material used by the contractor in the works, then in such a case, it shall be lawful to the WAPCOS and it will have the right and be entitled to recover the amount paid in the circumstances as aforesaid from dues of the contractor

1.3 Billing and Payment

Bidders are advised to execute LUT and should be able to supply goods and services at zero rate through LUT. The CSEZ Developers/units have been exempted from Payment of Customs Duty for goods or services imported into SEZ for its authorised operations in terms of Section 26 of SEZ Act, 2005. As per 16(1) of Chapter VII of IGST Act, all supplies of goods or services or both to SEZ Developer and Units are zero rated. Accordingly bidder shall submit LUT if already registered. If not registered till date of submission of bid, bidder shall hereby agree that they will get registered before submission of bills. For the purpose of availing this exemption, billing address should be taken as “The Chairman, CSEZ Administrative Building, and Kakkanad -682037.”

1.4 Obligations of WAPCOS/CSEZA

1.5 Defect Liability Period

The Contractor is expected to rectify any defects found in the Works due to defective construction practice or poor quality of work and/or material for the Defect Liability Period of 1 years.

Notwithstanding anything mentioned with respect to the period of limitation of defect liability here in this contract, the contractor shall be liable to compensate the Client for any damages sustained either to the Project or to the Client/any third party (by virtue of the Project) attributable either to the defects/fault in the design of the Project or to the defects in materials/workmanship which could have been detected during the period of the Project. If such above rectification is not done by the contractor, the Client shall have the right to rectify the defect during the defect liability period and recover the expenses/cost incurred in such instance, along with compensation, if any from the contractor.

2.0 INSTRUCTIONS TO BIDDERS

3.0 SCOPE OF WORK

- a) Replacement of deteriorated ACB (Air Circuit breaker) 800 A, 4 Pole MDO 415 V,50 KA in Ring-3 MSB. ACB Original test certificate and Warranty Certificate should be submitted along with bills.

- b) Replaced deteriorated ACB (Air Circuit breaker) should be stored in store room of 110 kV substation, CSEZ, Kakkanad as direction of site Engineer.

Note:

- i) The Bidder are required to visit the site and confirm the specification, requirements and dimension of the existing ACB (Air Circuit breaker) 800 A, 4 Pole MDO 415 V,50 KA circuit breaker to be erected.

- ii) The ACB (Air Circuit breaker) 800 A, 4 Pole MDO 415 V,50 KA shall exactly meet the dimensional and other requirements with the existing pole structures to avoid any technical complications. The same shall be included in the scope of supplier.

- iii) Care shall be taken by the contractor while handling and installing the various equipment's and components of the work to avoid damage to the any part / structure / Building of the CSEZ. He shall be responsible for repairing all damage and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste materials arising out of the installation from the site of work.

- iv) Necessary instruments/tools shall be in contractor scope.

- v) Transportation charges are considered in the above scope

- vi) Supply of spare parts is not in contractor scope, however, if spares are provided during servicing period the same will be replaced.

WARRANTY

There should be minimum warranty of 1 years from the date of commission of ACB (Air Circuit breaker) 800 A, 4 Pole MDO 415 V,50 KA Circuit breaker. For any repairing work under warranty period, Bidders/Agencies should make their own arrangement to rectify the same along with the cost of labour charges, transportation and other charges, if any.

DEFECT LIABILITY PERIOD

The defect liability period will be 1 year from the date of commissioning. Any defect, shrinkage, settlement or other faults which may appear within the "Defects Liability Period" then within 12 months after the virtual completion of the works, arising in the opinion of the WAPCOS Ltd from materials or workmanship not in accordance with the contract, shall upon the directions in writing of the WAPCOS Ltd, and within such reasonable time as shall be specified therein, be amended and made good by the Contractor, at his own cost and in case of default the Employer may employ and pay other persons to amend and make good such defects, shrinkage, settlement or other faults, and all damages loss and expenses consequent thereon or incidental thereto shall be made good and borne by the Contractor and such damage, loss and expenses shall be recoverable from him by the Employer.
